

Video recordings for preliminary selection for the entrance examination Instrumental/Vocal Interpretation and Performance

1. Artistic-musical performance via video recording

- The recordings should be no older than 6 months.
- All files are to be designated with *Major_Surname_Composer_Work_Movement, Date* (e.g. Piano_Smith_Chopin_Etude op.10 No 2_Allegro_251130)
- The works or movements of the performance should be uploaded as a separate document in the cloud drive or, in the case of Youtube videos, directly in the playlist (see 1.2 Upload).
- All movements must be recorded completely, unedited and without cuts.
- Recordings of public concerts may be submitted if they meet the requirements.

1.1 Technology

- Recordings may be made with a mobile phone, camera or laptop computer.
- Video recordings must be made from a fixed camera perspective - the musician's hands and face must be visible.
- The video recording must be made without backlighting.
- The use of a stereo microphone is desired.
- The quality and format of the recordings should meet the following criteria:
 - .mov or .mp4 format
 - HD video (720p; 1080i; 1080p)
 - 256 kbit/s sound resolution

1.2 Upload

- All files are to be uploaded by the candidates to a cloud storage until the **1st of March 2026**.
- Eligible cloud services: YouTube (only one link (Playlist)), Google Drive, One Drive, Switch Drive, Cloud Drive or Dropbox. With other providers, please contact the secretariat.
- The link to the videos must then be provided on the ZHdK ONLA registration platform.

2.2 Ruling of the Legal Service ZHdK

Authentication
