Participants are responsible for taking out adequate insurance coverage. Zurich Dance Academy (taZ) declines any liability for any damages and loss of property.

### **State of Health**

With their application, participants declare that they are healthy, physically fit, able to engage fully in sports activities, and able to participate in the Entry Test without any restrictions. Participants take part in the test at their own risk. Zurich Dance Academy (taZ) should be notified in writing before the Entry Test of any allergies and of any necessary medication.

### **Participation**

Participants are required to follow the instructions of the jury and teaching staff without fail. Jury members and teaching staff reserve the right to exclude participants who repeatedly fail to follow instructions from the tests.

Every child is unique and has individual strengths. A negative response simply means that your child could not be considered for this training at this time. **The Entry Test cannot be repeated in subsequent years.** Please understand that individual inquiries cannot be accommodated.
