

# **Call for Proposals Urban Waters 2026**

#### What is Urban Waters 2026?

Urban Waters is an initiative within the framework of the "#hallowasser – Experience Zurich's Waters" funding program by AWEL. It enables artists and designers from ZHdK to realise existing or new artworks, performances, interactions, workshops, etc. on the theme of "experiencing water," with a particular focus on local water and bodies of water. We understand water in all its forms: as bodies of water, snow, ice, steam, urban waters, natural waters, plants and living organisms in water, etc. An impression of this is provided in the documentation of Urban Waters 2025. The exhibition and events are intended to offer guests and visitors meaningful and lasting experiences and insights. Participation or attendance is free of charge. Urban Waters runs from March 13 to April 12. Urban Waters includes two formats:

- Artworks and Installations, freely accessible, under the open sky
- Thematic events and performances (workshops, concerts, readings, film screenings, dance, theatre, etc.) on the topic of water, which bring together art, culture, and science. They take place primarily indoors.

#### Where is Urban Waters 2026 taking place?

Urban Waters 2026 will take place at the <u>GZ Wipkingen</u> and its surrounding area. The GZ is located near ZHdK and close to the flowing Limmat River, offering a striking and direct perspective on the theme of water. It is easily accessible by public transport and well-frequented throughout the year. The riverside path along the Limmat is especially popular with walkers. The GZ provides suitable indoor and outdoor spaces for events and art installations (see site plan below). Since some parts of the GZ are public space owned by the City of Zurich, specific regulations apply for outdoor installations. To clarify these, on-site visits will be held on Friday, July 11 at 9:00 a.m. and Friday, August 22 at 9:00 a.m. Meeting point is the pavilion at GZ Wipkingen.

### When does Urban Waters take place?

From March 13 to April 12, 2026, over a four-week period. The international <u>World Water Day</u> on March 22 will be integrated into Urban Waters.

# Who can submit a proposal?

Projects for the formats "artwork/installation" or "event/performance" can be submitted using the form by students, staff, or alumni of ZHdK. A jury will select the final contributions. These will receive financial support from ZHdK.

# Who is the audience?

Urban Waters is aimed at the general public of the city and canton, including both laypeople and experts, art and culture enthusiasts, and especially families.

# What are the options for my artwork or installation?

The artworks exhibited outdoors and freely accessible to the public should engage with local water (e.g., in the canton of Zurich). They may include paintings, photographs, textile works, interactive installations, sculptures, objects, etc. Each artwork will be labeled with the title and the artist's name. They must not emit any disturbing emissions (noise, light, etc.), must be weatherproof, theft-proof, safe to the public, and stable in the event of attempted vandalism. They should be removable after Urban Waters without leaving traces. Artworks may not be placed directly in the water of the Limmat, and trees in the park must not be affected. Power supply for objects installed outdoors is not possible. Possible locations for artworks are shown on the site plan below.

### How can I participate with an event or a workshop?

Urban Waters supports thematic workshops, readings, concerts, film screenings, dance, performances, theater, etc.—that is, time-based activities with an audience, mainly on weekends. Ideally, visitors can actively participate (e.g., in a creative studio). Here too, the focus is on experiencing local water for a broad public. Alongside artistic formats, we particularly support exchanges between art - science - society sustainability. The GZ Wipkingen provides a room for 40 people and a creative studio for 8 people. If an activity takes place outdoors, the applicable conditions must be met (no disturbing noise emissions, no amplifiers, safety at the Limmat, etc.). Events must not disrupt nighttime quiet hours.

# How does the selection process work?

Until 28 September 2025, you can submit your ideas for artworks or events using this form. The form must be completed in full. A jury from ZHdK and AWEL will select the final artworks and events by the end of October 2025. A dialogue will then begin with the selected artists for the concrete implementation. They will receive an agreement from ZHdK regarding funding and deliverables. After this, the installations, artworks, and events can be implemented with support and guidance from ZHdK.

#### What are the selection criteria?

Submissions will be evaluated based on the following criteria:

- Artistic Quality How innovative and compelling is the project?
- Experience of Water To what extent does the project convey a unique experience or perspective on the theme of water/bodies of water?
- Reference to Local Water How is a connection to local water (natural waters, urban waters, water in various forms and states) established?
- Fit with the Wipkingen/Limmat Location How well does the project integrate into the site?
- Interaction with Visitors How does the project engage with visitors? (Optional not mandatory)
- Effort vs. Experience vs. Quality How does the (budgetary) effort relate to the visitor experience or insight? What is the quality of execution?

### What support will I receive if selected?

Artworks can be supported with up to CHF 4,000, and events or workshops with up to CHF 3,000. A corresponding budget for labor and materials must be included with the application.

### Locations

Urban Waters will take place around the GZ Wipkingen (see plan and photos below).

### Indoor spaces for events and workshops in buildings No. 1 and 2:

- Red Hall (Rote Saal, No. 1): Usable for workshops, events, readings, concerts, etc., with 40 seats. It includes a sound system and projector. Seating is possible.
- Creative Studio (Kreativatelier, No. 2): Located in the Baupavillon, with approx. 20 workspaces for creative workshops with materials, paint, etc.

# Outdoor spaces for art installations:

- The Wipkingerpark lawn (Wipkingerwiese, No. 3)
- The Ampéresteg bridge (No. 4 only the side balustrades, interior side)
- The vertical wall on the left bank of the Limmat (No. 5)
- The right riverbank (No. 6) with stairs to the Limmat

The GZ has restrooms and a cafeteria. There is also a "Züri WC" in the Wipkingerpark. As the GZ will undergo renovation in March/April 2026, there will be minor construction-related limitations, but these will not affect the areas mentioned above.

Artists can state a preference for where their installation should be located. The exact placement will be decided in consultation with the permitting authorities and the GZ.





# The following restrictions apply:

- Wipkingerpark (No. 3) must continue to allow usual recreational activities (walking, views of the Limmat, seating, family playground, etc.) with no significant restrictions.
- The two heritage-protected children's pools (No. 7) must not be affected.
- Special regulations apply for tree protection (see below, document available in German only).
- All paths accessible by vehicles must remain clear for emergency and cleaning services.



#### **Communication of Urban Waters**

Urban Waters 2026 has its own website. ZHdK, in cooperation with the City of Zurich (GZ Wipkingen), will publicly promote Urban Waters through posters, social media, etc. Urban Waters will be included in the GZ Wipkingen's official program.

# **Review of Urban Waters 2025**

For anyone interested in getting an impression of Urban Waters 2025.

<u>Urban Waters 2025</u> took place throughout February at the Tiefenbrunnen lakeside swimming area. Artworks were displayed in the park of the swimming area, and on weekends, the pavilion hosted activities, performances, concerts, workshops, film screenings, and readings. Access to the art installations and all events was free and open to the public. Approximately 600 people attended the events. All contributions – from the installations to the events – were created by members of the Zurich University of the Arts (ZHdK).

The performances were accompanied by ZHdK artists as well as Urban Waters assistants. Overall, Urban Waters proved to be an unexpected success. 




# Wurzel- und Kronenbereich von Bäumen sind freizuhalten

Für den General-Guisan-Quai gelten besondere Vorschriften. Bitte die aktuell gültigen Auflagen beachten.




Installationen nur auf asphaltierten oder mit Naturund Verbundsteinen ausgestatteten Flächen aufstellen.




#### Marktstände


Grünflächen und Rabatten dürfen von den Installationen und deren Kundschaft nicht tangiert werden.




