

# Zurich Dance Academy (taZ)

## Easter School 2016 Terms

### Subject

The participation requirements of the taZ Easter School are governed by the Terms and Conditions of Zurich Dance Academy (taZ).

### Scope

The Terms and Conditions of Participation set forth here apply to taZ Easter School participants and their parents / legal representatives.

### Application

In submitting a completed and signed application to the taZ Easter School by the application deadline, the undersigned parent / legal representative hereby declares that he/she has taken notice of and accepts the Terms and Conditions of Participation set forth here. Written applications are legally binding and will be considered in the order received. Following the submission of applications, the undersigned parent / legal representative will receive written confirmation of the application and an invoice for settlement of the participation fees.

### Participation Fees and Terms of Payment

The taZ Easter School is subject to participation fees. Fees are published on the designated website of Zurich Dance Academy (taZ). Fees are payable *within 10 days of invoicing*. If payment is not received within the stipulated deadline of 10 days, participation will be cancelled.

### Cancellation

Cancellations will be accepted in writing only. Cancellations received three (3) weeks prior to the beginning of the Easter School will not be subject to charge. The full participation fees will be owed if a cancellation is received less than three (3) weeks before course commencement. Participants remaining absent from the Easter School unexcused will also be required to pay the full participation fees. If participation is cancelled before the beginning of the Easter School due to accident or illness, a refund of the full participation fees minus an administrative charge of CHF 40.00 will be granted provided a medical certificate is presented. Participants suffering an accident or illness during the Easter School without any fault on their part are not eligible for a refund of any share of the participation fees.

### Insurance, Liability for Accident/Illness/Damages

Participants are responsible for taking out adequate insurance coverage. Zurich Dance Academy (taZ) declines any liability for any damages and loss of property.

### State of Health

With their application, participants declare that they are healthy, physically fit, able to engage fully in sports activities, and able to participate in the training programme without any restrictions. Participants take part in the Easter School at their own risk. Zurich Dance Academy (taZ) should be notified in writing before the Easter School of any allergies and of any necessary medication. Participants are required to submit a medical certificate with their application.

**Participation**

Participants are required to follow the instructions of teaching staff without fail. Teaching staff reserve the right to exclude participants who repeatedly fail to follow instructions from individual sessions or from the entire Easter School. Participants excluded from the programme are not eligible for a refund of the participation fees.

**Course Cancellation**

Zurich Dance Academy (taZ) reserves the right to cancel the Easter School if not enough applications are received. In this case, participation fees will be refunded. Zurich Dance Academy (taZ) also reserves the right to replace teaching staff in case of illness or due to other unforeseeable circumstances.

**Use of Sound Recordings, Images, Personal Details**

With their application, participants and their parents/legal representatives declare their consent that Zurich Dance Academy (taZ) may take photographs and film recordings of the participant and that these materials may be disseminated and exhibited in public (including the Internet), as well as used for advertising purposes. Zurich Dance Academy (taZ) divulges no personal details and addresses of participants to any third parties.

**Applicable Law, Place of Jurisdiction**

The Easter School of Zurich Dance Academy (taZ) is governed by Swiss law. The place of jurisdiction is Zurich.
